## The Vigil Honor

The Vigil Honor is the highest honor that the Order of the Arrow can bestow upon its members for service to the lodge, council, and the whole of Scouting. Vigil membership cannot be won by a person's conscious endeavors. The Vigil Honor is a high mark of distinction and recognition reserved for those Arrowmen who, by reason of exceptional service, personal effort, and unselfish interest, have made distinguished contributions beyond the immediate responsibilities of their position of office to one or more of the following:

- Lodge
- Order of the Arrow
- Scouting Community
- Scout Camp

Under no circumstances should tenure in Scouting or the Order of the Arrow be considered as reason enough for a Vigil Honor recommendation.

## Requirements

Any member of the Order of the Arrow who, at the time of recommendation, has been a Brotherhood member for a minimum of two years is eligible for recommendation to the National Order of the Arrow Committee for elevation to the Vigil Honor. A Lodge may nominate a maximum of two percent of their registered Arrowmen once a year. At least 50 percent of all those nominated must be youth, under 21, at the time of nomination.

## **Nominations Process**

Each year the Lodge strives to recognize its most worthy members with the Vigil Honor. These selections are made with great care, and only after thorough consideration. This nomination form has been designed to provide the necessary information to assist the selection committee with making these important decisions. The Lodge Vigil Selection Committee will conduct their annual selection meeting for 2021 at Cherokee Scout Reservation on Sunday, April 25th, 2021. The floor will be open for in-person nominations beginning at 2:00pm. Nominations for the Vigil Honor may also be made to the Selection Committee by the return of this form to the council office or by email to lodge70@lodge70.org. Early submissions need to be made by April 22nd to ensure they are received and reviewed by the selection committee. If you choose to make an in-person nomination to the committee, we still require that you bring this complete form for the committee to review. Please attach a photo of the person being nominated for the Vigil Honor, if possible. The Vigil Selection committee is comprised of only Youth members. Adults do not vote for Vigil Honor recipients.
